- Installed in accordance with MANGARIS® installation guidelines provide by Tata Enterprises, Inc.

Purchaser's sole remedy for any claim whatsoever, whether in contract, warranty, tort, or strict liability, arising from the purchase or use of MANGARIS® including, without limitation, any claim that MANGARIS® failed to perform as warranted above, shall be replaced with substitute MANGARIS®. To obtain replacement, the original owner must send: (1) this warranty card; and (2) the original purchase receipt or invoice indicating the date of purchase from an authorized MANGARIS® dealer by the original owner of a professional contractor on behalf of the original owner, and showing the purchase of at least the amount of MANGARIS® claimed to have suffered damage.
